2025 ANNUAL GOLF PASS AGREEMENT

This is an Annual Agreement for an Annual Golf Pass between the Heather Ridge Golf Course and the individual listed below. As a Golf Club at Heather Ridge Annual Pass holder, you agree to the following:

- 1. An Annual Golf Pass is extended only to the individual listed in the application.
- 2. All Pass holders are eligible to reserve individual tee times 10 days in advance.
- 3. All Pass holders are entitled to unlimited golf.
- 4. All Pass holders are entitled to one bucket of balls each day a round is played. All range balls and baskets are to remain on the Heather Ridge Golf Course property. Removal of balls or baskets from the property will terminate this agreement without refund.
- 5. All Pass holders are required to check in at the pro shop 20 minutes prior to beginning play.
- 6. All Pass holders are required to abide by the the Golf Club at Heather Ridge Cart Rental Agreement and are required to sign for cart rental for each round.
- 7. All Pass holders must comply with the cancellation policy regarding tee times.
- 8. All tee times reservations and/or changes to the booking must be made by phone or in person no later than 24-hours prior to the scheduled tee time. A confirmation will be sent of the cancellation. If the reservation or change to the reservation is not cancelled within 24 hours prior to your tee time, the Annual Pass holder's credit card that is on file will be responsible for all applicable posted fees for all player booked with the credit card being automatically charged.
- 9. All Pass holders are responsible for their conduct and the conduct of any guests.
- 10. All Pass holders and guests are required to adhere to all golf course policies and procedures.
- 11. Each golfer must have his/her own clubs.
- 12. Carts are designed for only two passengers. Annual Pass holder's along with all golfers will be required to ride with another golfer in the group. No single riders in a foursome. Depending on cart availability, an Annual Pass holder may be able to pay an additional fee to ride alone. This is the discretion of the Pro Shop attendant on duty.
- 13. During inclement weather, it may be necessary to close the golf course facility. This may include the golf course, putting green, and the driving range.
- 14. The Golf Club at Heather Ridge employs marshals who will keep play moving, assist patrons with information and enforce golf course policies.
- 15. Tournament play, including Men's Club, Ladies Club and outside tournaments, may be scheduled on any given day and time.
- 16. The Golf Club at Heather Ridge provides a restaurant where food and beverage may be purchased. No outside alcoholic beverages may be brought on to the premises. This is a violation of the State of Colorado liquor laws and may result in your removal from the golf course and possible prosecution.
- 17. The Golf Club at Heather Ridge reserves the right to adjust non-pass holder golf rates.
- 18. The "Cart path only next to Green and Tees" will be strictly enforced. If you violate this policy, you may be refused access to golf carts and the golf course.

Any deviation to the policies and procedures listed above, may include suspension and/or termination of the Annual Golf Pass without refund.
